

# Working with AutoCAD 2008 and Section 508

Section 508 requires that federal agencies' electronic and information technology is accessible to people with disabilities. The Center for Information Technology Accommodation (CITA), in the U.S. General Services Administration's Office of Government-wide Policy, has been charged with the task of educating federal employees and building the infrastructure necessary to support Section 508 implementation.

With this white paper, Autodesk offers background information to help our customers understand the accessibility features of Autodesk's AutoCAD® 2008 software, in the context of the Section 508 standards. This was done with the intent to enable agencies to be compliant with the Section 508 regulations.

The document contains subsets of the Electronic and Information Technology Accessibility Standards as published in 36 CFR Part 1194 and provides an analysis of AutoCAD as compared to these standards.

For the purposes of this paper, "AutoCAD" refers to AutoCAD 2008 and all Autodesk® industry products that are based upon the AutoCAD 2008 platform, including AutoCAD LT® 2008.

The first table of the Template provides a summary view of the section 508 Standards. The subsequent tables provide more detailed views of each subsection.

There are three columns in each table. Column one of the Summary Table describes the subsections of subparts B and C of the Standards. The second column describes the supporting features of the product or refers you to the corresponding detailed table, "e.g., equivalent facilitation." The third column contains any additional remarks and explanations regarding the product. In the subsequent tables, the first column contains the lettered paragraphs of the subsections. The second column describes the supporting features of the product with regard to that paragraph. The third column contains any additional remarks and explanations regarding the product.

This document is not intended to be a certification of compliance. This template is based upon version 1.2 (5/6/2004) supplied by the U.S. Government.

(a) When software is designed to run on a system that has a keyboard, product functions shall be executable from a keyboard where the function itself or the result of performing a function can be discerned textually.	Supports.	Keyboard navigation is provided for all Menu commands. Also, a Command Line allows the user to type in commands and other input.
(b) Applications shall not disrupt or disable activated features of other products that are identified as accessibility features, where those features are developed and documented according to industry standards. Applications also shall not disrupt or disable activated features of any operating system that are identified as accessibility features where the application programming interface for those accessibility features has been documented by the manufacturer of the operating system and is available to the product developer.	Supports.	Testing* has indicated that AutoCAD and AutoCAD LT software programs do not disrupt the accessibility features of other products on the end-user's system.
(c) A well-defined on-screen indication of the current focus shall be provided that moves among interactive interface elements as the input focus changes. The focus shall be programmatically exposed so that Assistive Technology can track focus and focus changes.	Supports.	Focus is programmatically exposed through command line scripting, VBA and C++ programming interface.
(d) Sufficient information about a user interface element including the identity, operation and state of the element shall be available to Assistive Technology. When an image represents a program element, the information conveyed by the image must also be available in text.	Supports. <p>(k) Software shall not use flashing or blinking text, objects, or other elements having a flash or blink frequency greater than 2 Hz and lower than 55 Hz.</p>	<p>Supports.</p>	<p>AutoCAD and AutoCAD LT do not use flashing or blinking text.</p>
<p>(l) When electronic forms are used, the form shall allow people using Assistive Technology to access the information, field elements, and functionality required for completion and submission of the form, including all directions and cues.</p>	<p>Supports.</p>	<p>Microsoft Active Accessibility applications like the Narrator can be used to access particulars of the components of a form/dialog box.</p>
