

Trial Download Frequently Asked Questions

General

How do I learn how to use the AutoCAD LT 2008 software for this trial?

If you are already familiar with AutoCAD LT® software but would like an introduction to AutoCAD LT® 2008, check out the New Features Workshop, available when you first start AutoCAD LT. The New Features Workshop is a series of animated demos, tutorials, and feature overviews that will help you get up and running fast. It is also available from the Help menu, and online www.autodesk.com/AutoCADLT-nfw. If you are new to AutoCAD LT software or would like information about classes and courses in your area, please visit the Autodesk Authorized Training Center website at www.autodesk.com/atc.

How does this trial version differ from a purchased product?

Except for some licensing steps that you are required to take with the purchased AutoCAD LT 2008 product, there is no difference between the AutoCAD LT 2008 trial and the purchased product.

Can I get User Manuals for AutoCAD LT 2008 during the 30-day trial period?

No, manuals are not included with the trial version. To learn more about new features, you can use the New Features Workshop as your primary reference. You may also find the Help system to be a useful resource. The Help system is comprehensive and includes everything that is covered in the printed manuals, and more. The Help system is easy to use, as you can search quickly for the information you need. The Help system is available from the Help menu.

Does the AutoCAD LT 2008 trial software attempt to communicate with Autodesk?

No. However, you may initiate contact using some features within the product, but no personal information is transmitted through such a contact.

Availability

What media is the AutoCAD LT 2008 Trial available on?

The AutoCAD LT 2008 Trial is available on CD media only. The CD media contains only the 32 bit version of AutoCAD LT 2008. AutoCAD LT 2008 is not available on DVD media. There is no 64 bit version of AutoCAD LT 2008.

Who can use the AutoCAD LT 2008 trial?

Any person who completes the form and lives in the United States and Canada can use the AutoCAD LT 2008 trial. The trial download of AutoCAD LT 2008 may be available for download in other countries in the near future.

How many people can use the AutoCAD LT 2008 trial?

Only one AutoCAD LT 2008 trial is allowed per computer. That said, the trial software can be downloaded and installed on different computers and each will run for 30 days.

When does the AutoCAD LT 2008 30-day trial begin?

The 30 days begin when you run the AutoCAD LT software for the first time. To run AutoCAD LT 2008, double click the icon on your desktop or launch the application from your Microsoft® Windows® Start menu.

What counts as 30 days?

The AutoCAD LT 2008 trial runs for 30 consecutive calendar days from the moment you first run the application.

Can I extend my AutoCAD LT 2008 trial beyond the 30 days or sign up again for another 30 days?

No, only one 30-day period of the AutoCAD LT 2008 trial is possible per computer.

My trial download process was interrupted and I wasn't able to finish the download, what should I do?

You will need to re-register to initiate the download of the trial application again.

Do I have to uninstall the trial application before I install a purchased version of AutoCAD LT 2008?

Yes, it is recommended that you uninstall the trial prior to installing the purchased version of AutoCAD LT 2008.

What other Autodesk product trials are available?

Compatibility

Can I run AutoCAD LT 2008 side-by-side on my computer with AutoCAD LT 2006/2005/2004/2002 or other previously purchased Autodesk software?

Yes, AutoCAD LT 2008 is designed to run side-by-side with the AutoCAD LT® 2000i/2002/2004/2005/2006 versions, enabling you to make a smooth transition to the new AutoCAD LT release. The migration features of AutoCAD LT 2008 help you make a smooth transition to the new release by automatically migrating customized menus, hatch patterns, linetypes, command short cuts, and AutoCAD LT profiles.

Can I uninstall the AutoCAD LT 2008 trial without affecting my other software products?

Yes, but you must not uninstall shared files when prompted.

Will I lose access to any data from my current AutoCAD LT software while I use the trial?

No. Installing and running the AutoCAD LT Trial will not affect data or your other software. Even if you choose to migrate the settings from a previous version of AutoCAD LT to your AutoCAD LT 2008 trial installation, the previous installations and data will be unaffected.

Will any data that I create in the AutoCAD LT trial be useable in previous versions of AutoCAD LT?

Yes, data created in AutoCAD LT 2008 is backwards-compatible with AutoCAD LT 2004 and 2005.

Platform and System Requirements

The recommended system requirements for AutoCAD LT 2008 are as follows:

- Intel® Pentium® 4, 2.2 GHz Recommended
- Microsoft® Windows Vista™ Home Basic, Home Premium, Ultimate, Business and Enterprise, XP Home & Professional SP2, Windows® 2000 SP4

- 512 MB RAM
- 550 MB free disk space for installation
- 1024x768 VGA with True Color
- Microsoft® Internet Explorer® 6.0 SP1 or higher

*Free disk space for download and installation includes:

-400MB for the download file (the compressed Zip file)

-600 MB for the temporary files created in your TEMP folder

-550MB for the actual application and installation

-Once the application is installed, the downloaded file (~400MB) can be deleted, and your TEMP folder can be cleared (~600MB).
